On February 11, 2020, 813 shares of The PNC Financial Services Group, Inc. ("PNC") common stock vested pursuant to an award of performance-based restricted share (1) units granted to the reporting person in the first quarter of 2016 (the "2016 PRSUs"), based on achievement against the risk-based performance criteria established under the award. Pursuant to the award, the 2016 PRSUs pay out in shares of PNC common stock, and any accrued dividend equivalents are paid out in cash.
